Governors' Curriculum Statement (Upper School)

If you are unsure whether a particular item is appropriate, please contact the school for clarification before making any purchase. Full details of the correct uniform and PE Kit are given to all new students and further copies are available from the school reception.

School Uniform Procedures

If a student wears a non-uniform item of clothing to school, examples of actions taken are as follows:

Non uniform jackets/coats:	Confiscated and returned at the end of the day.
Shoes:	Note written in student planner by Form tutor, informing parents that a doctor's note is needed, if black shoes are not worn.
Tie:	Directors of Student Development will lend a tie for use on that day.
Jewellery:	No jewellery to be worn. Only stud earrings are allowed.

Students may be sent home to change into appropriate uniform, at the discretion of Directors of Student Development, following contact with parents.



STUDENT CODE OF CONDUCT AND RULES

All students who are part of the Preston Manor School community are required to have a proper regard for the authority of staff and treat all persons in authority with courtesy and respect.

Underpinning our ethos is a respect for and consideration of the views of students but equally we believe that respect has to be given in order to be received. We therefore expect students will show consideration and respect for others and learn and behave to the best of their ability at all times.

Poor behaviour from any student will not be tolerated as it is a denial of the right of their peers to learn and teachers to teach. Consequently, if the Student Code of Conduct and Rules are not fully observed, students can expect to be sanctioned.

Every student at Preston Manor has the following responsibilities

- Responsibility to be punctual
- Responsibility for their own learning and for not hindering the learning of others
- Responsibility for their own behaviour and their behaviour towards others
- Responsibility for the learning environment
- Responsibility for their uniform and appearance

On arrival to lessons students should

- enter the room in a calm and quiet manner
- sit in their specified seat and take off their coat immediately
- take out their planner, the required equipment and books whilst the register is taken in silence
- put any bags under the table
- delay all questions until the teacher has started the lesson and has time to deal with individual concerns
- show they are ready to learn by not talking and facing the teacher

During lessons students should

- record all home learning in their planner
- engage in tasks and learn to the very best of their ability
- not interfere with the learning of other students
- listen and follow instructions
- not shout out or interrupt others who are speaking
- take pride and care in the presentation of work
- not chew gum in class (or anywhere in school)
- by doing all of the above- allow the teacher to teach and others to learn

At the end lessons students should

- leave their working area clean and tidy
- ensure their chair is placed under their table
- leave the room in a calm and orderly manner

On the way to their next lesson or break students should

- walk on the left in the corridors
- not eat or drink in the corridors
- not leave litter around the school site
- move around the school site quickly, calmly and quietly



In communal areas like the Dining Hall and playgrounds students should

- place all litter in the bins provided
- respect the green spaces
- use footballs only on the field
- not gather in large groups which may make others feel uncomfortable
- start to make their way towards their lesson 5 minutes before the buzzer

When out in the wider community each student should

- follow all staff instructions immediately to leave the front gates and other areas of the school by 3.30 pm
- never associate with any 'outsiders' whether known or unknown to the school, either at the school gate or in the close vicinity
- behave responsibly and use appropriate language
- wear full school uniform to and from school
- maintain positive behaviour on transport, educational visits and other off-site placements
- Show consideration to members of the public

CHALLENGE TO STAFF

The school will adopt firm measures against abuse or intimidation of staff by students. This includes unacceptable conduct by students when not on the school site or outside of school hours when not under the charge of a member of staff of the school.

MOBILE PHONES

- Mobile phones are forbidden in school.
- **Mobile phones discovered switched on or being used at any time or place during the school day will be confiscated and passed to the relevant DSD.**
- Only a parent or guardian can collect the mobile phone by prior arrangement.
- For second and subsequent offences mobiles will be retained for a period of one week

PERSONAL STEREOS, ELECTRONIC GAMES PLAYERS ETC

- Such items should not be brought into school
- Students caught listening to music or wearing earphones at any time while on the school site **will have their equipment confiscated and passed to the relevant DSD**
- For second and subsequent offences equipment will be retained for a period of one week

INFRINGEMENTS OF UNIFORM POLICY

- Only correct school uniform must be worn.
- **Any excessive or additional jewellery or clothing items which are not part of the school uniform requirements will be confiscated and passed to the relevant DSD.**
- If this is not possible, eg. trainers are being worn instead of shoes, then students will be sent home to change
- For second and subsequent offences items will be retained for a period of one week

TOBACCO, MATCHES, LIGHTERS, ALCOHOL, KNIVES OR OTHER DANGEROUS OR ILLEGAL SUBSTANCES OR WEAPONS

- It is forbidden to bring any of these items onto the school site

Any student who breaks any aspect of the Student Code of Conduct and Rules can expect to be sanctioned. **FAILURE TO COOPERATE WITH STAFF OR TO HAND OVER ANY ITEM REQUESTED WILL BE TREATED AS A VERY SERIOUS MATTER.**

ADMISSIONS POLICY 2018-2019

Admission to Reception under Local Authority Arrangements

The school's admission number for Reception places in September 2018 is 60. Applications are made through the Local Authority online facility; www.eadmissions.org.uk. This website can be used for primary applications from 1 September 2017 until the deadline.

Admission to Year 7 under Local Authority Secondary Transfer Arrangements

The school's admission number for Year 6 transfer into Year 7 in September 2018 is 252. Applications are made through the Local Authority online facility; www.eadmissions.org.uk. This website can be used for secondary applications from 1 September 2017 until the deadline.

In Year Admissions

From Reception to Year 11 you must the school. Unsuccessful applicants will be placed on the waiting list.

Children with a Statement of Special Educational Needs

If your child has a statement of Special Educational Needs the Local Authority will process your application for a school place as it is their responsibility to arrange SEN provision and consider the suitability of individual schools.

Right of Appeal

If the school is unable to offer a place there is a statutory right of appeal to an independent Appeal Panel.

Appeals under the Co-ordinated Admission Scheme

Admissions appeals for on-time applications (i.e. those relating to decisions sent on national offer date) will be heard by 6 July or earlier.

Appeals must be lodged within 20 school days from the date of notification that the application was unsuccessful. Please contact the school for a Preston Manor School appeal form (which should be returned to the Clerk to the Independent Appeal Panel c/o Preston Manor School, Carlton Ave East, Wembley HA9 8NA).

Late Applications under the Co-ordinated Admission Scheme

The school will comply with the Local Authority regarding Late Applications as detailed in the Local Authority's Secondary School Guide.

Waiting Lists

Lists will be maintained by the school throughout the school year. A child's position on the waiting list does not depend upon the time they have been on the list but will be determined by how they meet the oversubscription criteria.

This means that a child's position on the list can go down as well as up, depending upon the child's circumstances and those of other applicants. The waiting list will be closed each year and will not roll over. Parents wishing to stay on the waiting list will be required to apply directly to the school at the beginning of each academic year.



“Hard To Place” and Excluded Students from Other Schools

The school will work closely with the Local Authority, in accordance with local protocols, regarding students who fall into these categories. Children who are the subject of a direction by a local authority to admit or who are allocated to a school in accordance with an In-Year Fair Access Protocol, **must** take precedence over those on a waiting list.

This policy is reviewed by the Admissions Committee on behalf of the Governing Body on an annual basis.

Over Subscription Criteria

Where applications exceed the number of places available, offers of places will be made using the following criteria in order of priority:

- i. **children in public care (looked after children)** a 'looked after child' or a child who was previously looked after but immediately after being looked after became subject to an adoption, child arrangements, or special guardianship order.
An application for admission to the school must be made by the person with parental responsibility and / or the child's social worker.
- ii. **children who have a brother or sister** (including blood, half, step, adoptive or foster who live at the same home address) attending the school in the year in which the application is made and will continue to be on roll at the date of admission.

Twins, Triplet and other children of multiple births

In the event that the school has one place to offer and the next child on the waiting list is one of twins, triplets or other children of multiple births, the policy of the school is not to separate them even if this means that the school will temporarily go over the published Admissions Number.

(**Note:** brother or sister connections will only be considered if the brother or sister is currently attending the school including the sixth form and will continue to be on roll on the date of admission)

- iii. **children for whom it is essential to be admitted to Preston Manor School because of special circumstances to do with significant medical needs, social needs or special educational needs.** The recommendation must be received in writing from a consultant at a NHS hospital or equivalent. This criterion relates to the **child's** medical, social and special needs and does not include any other member of the child's family. The supporting evidence should set out the particular reasons Preston Manor School is the most suitable school and difficulties that would be caused if the child had to attend another school.
- iv. **children who have attended Preston Manor Lower School and completed Year 6.**
- v. **children of Preston Manor School staff, teaching and non-teaching, who have been employed for two or more years, or who will meet a skills shortage.**
- vi. **proximity to the school** (for children who do not fall within criteria i – v) distance will be measured in a straight line from the front door of the child's permanent address (including flats) to the school reception, [using the Local Authority's computerised measuring system], with those living nearest to the school being accorded the highest priority.

Tie Breaker

If two or more students have equal priority under criteria i - v, the criterion of proximity to the school will apply with those living nearest to the school (in a straight line from the front door of the child's permanent address to the school reception) being accorded the highest priority.

Notes

Distance does not take into account access by public transport or any private vehicle.

Where a child lives with parents with shared responsibility, each for part of a week, the address where the child lives is determined using a joint declaration from the parents stating the pattern of residence. If a child's residence is split equally between both parents, then parents will be asked to determine which is the residential address for the purpose of admission to school. If the residence is not split equally between both parents then the address used will be the address where the child spends the majority of the school week.

252 places were offered and 252 were accepted. There were 15 appeals lodged against non-admission and all were invited to attend an Appeal Hearing on 12 June 2017 at the school. 14 cases were heard on this day and 2 were upheld.

Appeal Procedure

If the school is unable to offer a place there is a statutory right of appeal to an independent Appeal Panel. Parents have the right of appeal against a decision not to admit a child.

Appeals must be lodged within 20 school days from the date of notification that the application was unsuccessful. Please contact the school for a Preston Manor School appeal form (which should be returned to the Clerk to the Independent Appeal Panel c/o Preston Manor School, Carlton Ave East, Wembley HA9 8NA).

Parents are entitled to attend the Appeal Hearing to give grounds for their appeal personally and/or to be represented. Parents will be informed in writing of the results of their appeal.

Secondary admissions round – appeals for on-time applications (i.e. those relating to decisions sent on national offer date) will be heard by 6 July or earlier.

Application for Secondary School Place

To begin your application you will need to visit www.eadmissions.org.uk. From here you can apply online will be given clear instructions on how to make your application. If you apply online you do not need to submit a paper application. If you still have difficulty in applying online, you can still submit a paper application by contacting the Children's Team at Brent Customer Services. Provision for our More Able Students

At Preston Manor Upper School we have an excellent track record in nurturing the abilities of all students so that they can achieve their full potential. Nearly 100% of our VI Form students go on to universities which include Oxford and Cambridge and the very best Russell Group universities.

In line with current research and thinking, we have replaced the term 'Gifted and Talented' with 'More Able' and those students are now identified according to a broader and more flexible set of criteria; students who are flourishing are able to be included mid-year.

More Able students' work and achievement is regularly and closely monitored to maximise progress and impact and to enable teachers to provide suitable challenge, stretch and stimulation for them across all subjects and in targeted development activities that meet their particular learning and social needs.

We are responding to the recommendations of academic research which "focus on the expandability of students' minds rather than their fixedness.." and aim to "promote a 'learning culture' rather than a 'performance culture'.."

Enrichment opportunities both inside and outside of school involving a range of external organisations also provide exciting opportunities for our More Able students. Opportunities to develop critical and creative capacities exist in a range of subjects; these are designed to raise aspirations by stimulating students and broadening their horizons.

MENTORING AT PRESTON MANOR SCHOOL

Preston Manor has a highly acclaimed Peer and Learning Mentor Programme. Meetings between mentors and mentees take place in a dedicated suite that offers a relaxed environment and high tech computers. A group of trained and committed Sixth Form student peer mentors work with enthusiasm alongside experienced adult mentors drawn from the community, other education institutions and our business partnerships. As appropriate, students can be offered individual professional counselling through the school's partnership with the Brent Centre for Young People.



Preston Manor School's Mentoring Programme aims to enhance the learning opportunities of students who need support in overcoming a variety of barriers that prevent them from achieving their full potential from the school curriculum. The programme aims to empower those targeted students by raising their self-esteem and self-awareness and by preparing them for the opportunities, responsibilities and experiences of adult life.

Mentoring is:-

1. An additional resource for the support of students.
2. A complementary service that enhances learning and life skills.
3. A valuable resource and also very popular with students.

Who are the mentors?

The Learning Mentor Programme at Preston Manor School utilizes a selection of people to make this programme as successful as it currently is.

1. Year 12 students from Preston Manor School
2. Ex-students from Preston Manor School
3. Preston Manor Staff
4. Adults from Mentoring Organisations
5. Parents

Each mentor is suitably trained and appropriately matched with student mentee to address and monitor the individual needs of the targeted student.

Mentors are fully supported in their role; they meet several times throughout the year, they are required to undertake 'Initial Mentor Training' and are given the opportunity to attend workshops / further training sessions.

Group Mentoring - Leadership Training

S.T.A.R.S. – Successful Talented Astonishing Responsible Students

Over the last four years Mr. Carboo has developed the S.T.A.R.S program. This project is aimed at students we feel would benefit from Leadership training. The programme is run by Mr. Carboo (Preston Manor Lead Learning Mentor).

The S.T.A.R.S. Mentoring Programme is a unique initiative that aims to motivate and inspire students to achieve their true potential. The real power of the programme lies in personal learning and development through exposure to new ways of thinking and behaving. The group sessions will run on a different period each week in Preston Manor for one academic year. The sessions aim to increase the pupils' motivation, learning and self-esteem. In addition the sessions will be creative, interactive, thought provoking, challenging, and above all enjoyable.

Students are required to undertake numerous challenges and become skilled in many different areas. Challenges include: Public speaking, debates, presentations, chess club, 36 chambers of STARS challenge, and the 7 day detox.

The rules of the 7 day detox challenge are simple. For 7 days we are asking young people to adhere to the following:

- No TV Programmes
- No computer games
- No Games on the phone (Candy Crush etc)
- No Arguments / Fights
- No negative Music that promotes aggression, crime or death
- No Social Media NO Facebook, Twitter, Snap Chat, WhatsApp

Students are also required to undertake various challenges each morning, and evening including research, writing, self-develop activities. Students all present their work, diaries, and experiences at the end of the week.



B.B.C. – Black Boys Council

The black boy's council (B.B.C.) IS A programme run through Preston Manor's mentoring programme. The B.B.C is made up of nominated group of boys who have been chosen by their DSDs and Tutors to participate. The boys act as positive black role models within and across the school.

The members of the B.B.C. are proactive in developing activities that assist in improving the school from the perspective of students. There are 15 boys in the B.B.C who are very intelligent. The B.B.C was put together by Mr. Carboo and Mr. Ward. The aim of the group was to improve behaviour and attitudes of black boys in the school.

The B.B.C. is a very motivational programme that has been on many inspirational visits such KPMG, BT, Outward Bounds residential trip and trips to the House of Lords.

All the nominated students have the opportunity to further develop their level of communication, aspirational targets, and confidence related to working within a positive team. There will also be opportunities to visit successful businesses, personalities and have motivational speakers who will present on the importance of high ambition and education in the school.

Who are the mentees?

While all young people can benefit from the opportunity to talk with an adult other than a teacher or parent, PMS targets the following students for mentoring;

1. Gifted and Talented students
2. Vulnerable students
3. Students with behaviour issues, low motivation and / or self esteem
4. Students that are not fulfilling their potential
5. Students with attendance and / or punctuality issues
6. Underachieving students
7. Refugees

What is the referral procedure?

Heads of Year and or form tutors make all referrals directly to the Lead Learning Mentor or Interventions Co-ordinator. Upon receiving the referral forms the Lead Learning Mentor and Assistant Learning Mentor will consider the information provided and make the appropriate placements.

How long does mentoring last?

Mentoring relationships usually lasts for an academic year. The length of the mentoring relationship can be shortened or extended according to the needs of the student.

The focal point of mentoring is centred on individual relationships which take time to build. The needs of each student will vary greatly. This makes it difficult to be firm about how long mentoring should last. Meetings between mentor-mentee may gradually become less frequent as the need of the mentee changes.

Learning Mentors do not only make a difference to students themselves, they also have a considerable impact on families, teachers, the school community and the way they function, and society as a whole.
